Dear Mr. Stawick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (“Act”), and section §40.6(d)(2)(iv) of the regulations promulgated by the Commodity Futures Trading Commission (the “Commission”) under the Act (the “Regulations”), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. (“Nadex”, the “Exchange”) hereby provides notice that it has added additional strike levels in its Weekly Corn and Soybean Binary Contracts, and in its Daily Soybean Binary Contracts on Trade Date January 30, 2013, and in its Daily EUR/JPY Binary Contracts on Trade Date February 1, 2013. Nadex returned to its regular listing schedule for its Daily Soybean contracts on January 31, 2013. Nadex plans to return to its regular listing schedule for its Weekly Corn and Soybean Binary Contracts and its Daily EUR/JPY Binary Contracts on February 4, 2013.

New strikes created on trade date January 30, 2013 and February 1, 2013 are set forth in Exhibit A.

Nadex hereby certifies that the additions contained herein comply with the Act, as amended, and the Commission Regulations adopted thereunder.
