The Board of Trade of the City of Chicago, Inc. ("CBOT" or "Exchange") hereby notifies the Commodity Futures Trading Commission of amendments to Chapter 7 in the Interpretations & Special Notices Relating to Chapter 7 section of the CBOT Rulebook. The Exchange has approved a regularity facility for the delivery of oats at a new location. Additionally, CBOT has approved an increase in regularity for ethanol at the Argo, IL location.

The rule changes are attached, with additions underscored and deletions lined-out. The amendments will be made effective immediately.
