Previously, pursuant to Submission No. 13-051 dated February 20, 2013, the Chicago Mercantile Exchange Inc. ("CME" or the "Exchange") notified the Commodity Futures Trading Commission ("Commission") that it planned to implement a USD/CNH Volume Incentive Program ("Program").

In this letter, CME is providing the Commission with certain additional information related to the incentives under the Program. By e-mail dated today, February 20, 2013, the Chicago Mercantile Exchange Inc. ("CME") submitted a supplemental rule certification filing (submission No. 13-051S) to the Commodity Futures Trading Commission (the "Commission"). This supplemental filing includes an appendix ("Appendix A"), which is attached.

Pursuant to Sections 8 and 8(a) of the Commodity Exchange Act ("CEA"), as amended, and Commission Regulation 145.9(d), CME requests confidential treatment of Appendix A on the grounds that Appendix A contains confidential commercial information of the submitter (CME).
