Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended ("Act"), and section §40.6(d) of the regulations promulgated by the Commodity Futures Trading Commission (the "Commission") under the Act (the "Regulations"), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. ("Nadex", the "Exchange") hereby provides notice that it has added additional strike levels in its Weekly EUR/JPY, GBP/JPY, and USD/JPY Binary Contracts on trade date February 27, 2013. Nadex plans to return to its regular listing schedule for these contracts on March 4, 2013.

New strikes created on trade date February 27, 2013 are set forth in Exhibit A.
