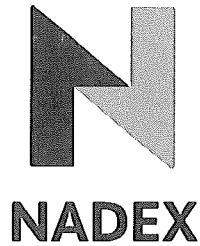

RE: Weekly Notification of Rule Amendments: Nadex Adds Strikes in its Daily Gold, Silver, Germany 30, US Tech 100, and Wall St 30 Binary Contracts for Trade Date March 6, 2012, and in its Daily EUR/USD Binary Contracts for Trade Date March 9, 2012 – Submission Pursuant to Commission Regulation §40.6(d)(iv)

Dear Mr. Stawick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (“Act”), and section §40.6(d)(iv) of the regulations promulgated by the Commodity Futures Trading Commission (the “Commission”) under the Act (the “Regulations”), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. (“Nadex”, the “Exchange”) hereby provides notice that it has added additional strike levels in its Daily Gold, Silver, Germany 30, US Tech 100, and Wall St 30 Binary Contracts on a discretionary basis for trade date March 6, 2012. Nadex returned to its regular listing schedule for these contracts on March 7, 2012. Additionally, Nadex added additional strike levels in its EUR/USD Binary Contracts on a discretionary basis for trade date March 9, 2012. Nadex plans to return to its regular listing schedule for these contracts on March 12, 2012. New strikes created on trade dates March 6 and March 9, 2012 are set forth in Exhibit A.

Nadex hereby certifies that the revision contained herein complies with the Act, as amended, and the Commission Regulations adopted thereunder.
