Pursuant to section 5c(c)(1) of the Commodity Exchange Act, as amended (the "Act"), and section 41.23 of the regulations promulgated by the Commission under the Act, submitted herewith are contract specifications for a new product or products, as appropriate, (the "New Product") that will be listed for trading on OneChicago, LLC ("OneChicago") effective, 3/29/2011. The New Product will be subject to the Rules set forth in Chapter IX of the OneChicago rulebook, as supplemented by the specifications supplement attached hereto as Appendix A.
