Previously, pursuant to Submission No. 13-095 dated March 15, 2013, Commodity Exchange, Inc. ("COMEX" or the "Exchange") notified the Commodity Futures Trading Commission ("Commission") of that it planned to implement a Copper Options Resting Order Incentive Program ("Program").

By e-mail dated today, March 15, 2013, the Commodity Exchange, Inc. ("COMEX" or the "Exchange") submitted a rule certification filing to the CFTC (Submission No. 13-095S). This supplemental filing includes an appendix ("Appendix A"), which is attached.

Pursuant to Sections 8 and 8(a) of the Commodity Exchange Act ("CEA"), as amended, and Commission Regulation 145.9(d), the Exchange requests confidential treatment of Appendix A on the grounds that Appendix A contains confidential commercial information of the submitters (the Exchange). A detailed written justification for this request is attached hereto as Exhibit 1. Pursuant to Commission Regulation 145.9(d)(5), COMEX requests that confidential treatment be maintained for Appendix A until further notice from the Exchange.
