Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended, and Commission Regulation 40.6, ICE Futures U.S., Inc. ("Exchange") submits, by written certification, an amendment to Floor Trading Rule 4.07, attached as Exhibit A, which extends the open outcry trading session for Cotton No. 2 options contracts by opening trading at 8:15 am instead of 10:30 am.

The Exchange certifies that the amendment complies with the requirements of the Commodity Exchange Act and the rules and regulations promulgated thereunder.
