Re: Rule Certification. New York Mercantile Exchange, Inc. Submission #10-074: Notification of Expansion of Listed Contract Months for Five (5) Energy Contracts

Dear Mr. Stawick:

The New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying the expansion of listed contract months for the five contracts listed below such that the contracts are listed through the current calendar year plus the next consecutive five (5) full calendar years. For each of the contracts listed below, following the termination of the December contract month, a new full calendar year will be added on an annual rolling basis. These contracts are listed for trading on the NYMEX trading floor and for clearing through CME ClearPort[®]. The expansion of listed months for the contract will become effective Sunday, April 11, 2010 for trade date Monday, April 12, 2010.
