Pursuant to Commodity Exchange Act ("CEAct") Section 5c(c)(1) and Commodity Futures Trading Commission ("Commission") Regulation 40.6(a), the Minneapolis Grain Exchange ("MGEX") hereby certifies that the attached amended Resolution 1402.00.C. complies with the CEAct and the regulations promulgated thereunder. Additions have been underlined while deletions have been marked through.

The purpose for amending the Resolution is to revise the last trading day and expiration for January 2010, December 2010 and January 2011 Spring Wheat options contracts so as to minimize scheduling issues in connection with the various holidays. There is no open interest in any of the contracts. Additionally, as a housekeeping matter, the amendment regarding the December 2007 Spring Wheat options has been deleted. The amendments do not materially change the terms or conditions of the contracts.

Pursuant to the authority of MGEX Rule 210.01., the Board of Directors unanimously approved amending the Resolution. The MGEX plans to implement the changes the next business day after receipt of this submission to the Commission.
