Rule Certification. New York Mercantile Exchange, Inc. Submission #10-Re: Notification of Administrative Amendments to Chapter 5, Position 076: Limit, Position Accountability and Reportable Level Table of the NYMEX **Rulebook for Three (3) Existing Contracts**

Dear Mr. Stawick:

The New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying amendments to the Position Limit, Position Accountability and Reportable Level Table located in the Interpretations and Special Notices Section of Chapter 5 of the NYMEX Rulebook. The amendments adjust the any one month accountability level for the Gasoil 0.1 (Platts) Cargoes CIF NWE vs. ICE Gasoil Swap Futures (Chapter 537, Code TU), the aggregation allocations for the Regional Greenhouse Gas Initiative (RGGI) CO₂ Allowance Vintage 2010 Futures (Chapter 873, Code 76) and Singapore Fuel Oil 180 cst (Platts) Average Price Option (Chapter 493A, Code C5).

Pursuant to Section 5c(c) of the Commodity Exchange Act ("Act") and CFTC Rule 40.6, the Exchange hereby certifies that the attached rule amendments comply with the Act, including regulations under the Act. These changes will be made effective on trade date March 25, 2010.
