ADVISORY NOTICE

Amendments to List of EUAs and CERs Not Accepted for Delivery for GreenX EUA and CER Futures Contracts

To: Participants /Customers

From: Green Exchange ("GreenX")

Notice Date: April 6, 2011

On April 5, 2011, the Green Exchange ("GreenX") issued Advisory Notice # 2011-06 announcing the resumption of trading of the Daily European Allowance (EUA) Futures contract. Included as an attachment to that Advisory was a list of the European Union Allowances and Certified Emission Reductions (CERs) not acceptable for delivery under certain GreenX contracts noted below.

The Exchange has received additional information relating to specific EUAs and CERs on that list and consequently has hereby attached an amended list effective today, April 6, 2011. Specifically, we have received further information regarding the block of serial numbers reported as both EUAs and CERs. With further information now available on the Project ID for the block of CERs alleged to have been stolen, we hereby remove Block # 8 and Blocks 163, 164 and 165 from the list.

The applicable contracts are as follows:

Certified Emission Reductions not acceptable for delivery under the:

- **In Delivery Month Certified Emission Reduction Futures contract (commodity codes: Globex = CRE & ClearPort = 6S)**
- **Certified Emission Reduction Plus (CERplusSM) Futures contract (commodity codes: Globex & ClearPort = CPL)**

- **Certified Emission Reduction (CER) Futures contract (commodity codes: Globex = CCR; ClearPort = VA).**

Please note that this Advisory Notice does not otherwise alter any GreenX Rules regarding the eligibility of CERs for delivery. In addition, these actions do not affect trading in any other futures or options products listed on GreenX.

The list below contains a total of 162 individual blocks corresponding to 2,960,491 EUAs. There is however a partial overlap between blocks 128 and 129 in the sheet, which means that the effective amount of EUAs not accepted for delivery is 2,947,391.

Also, block 8 was originally reported as both EUAs and CERs. With further information now available as to the Project ID of the block of CERs, these are now only listed as CERs (Block 166). This also results in the removal of the 3 additional blocks of CERs that matched the serial numbers reported. In summary, Block #8 and Blocks 163 to 165 have now been removed from the list of EUAs and CERs not accepted for delivery.

This list was compiled from various currently available public sources and **may be updated from time to time by GreenX**. Should GreenX receive any further information regarding potentially affected EUAs and CERs, GreenX will update and re-circulate this list as soon as reasonably practicable. Neither GreenX nor the Chicago Mercantile Exchange Inc. ("CME") Clearing House make any representation or warranty with respect to the completeness or accuracy of any list of allegedly stolen EUAs/CERs or any link provided as a source for the list.
