Notification of Administrative Amendments to NYMEX Chapter 9A,
Appendix A - Rules 9A.26 and 9A.27 – for Two Western Hub Electricity
Contracts**

Dear Mr. Stawick:

The New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying administrative amendments to NYMEX Chapter 9A, Appendix A, Rules 9A.26, All Month/Any One Month Accountability Levels, and 9A.27, Expiration Month Limits for two Western Hub electricity contracts.

The administrative amendments revert the levels and limits for the PJM Western Hub Peak Calendar-Month Day-Ahead LMP Swap Futures Contract (J4) and PJM Western Hub Off-Peak Calendar-Month Day-Ahead LMP Swap Futures Contract (E4) to the original launch levels and limits established as of December 4, 2008 (see NYMEX Submission #08.131). The accountability levels and expiration month position limits were lowered in error subsequent to the December 4, 2008 launch and in connection with the launch of additional 34 new electricity contracts on February 23, 2009 (see NYMEX Submission #09.21).

Pursuant to Section 5c(c) of the Commodity Exchange Act ("Act") and CFTC Rule 40.6, the Exchange hereby certifies that the attached administrative amendments comply with the Act, including regulations under the Act. These changes will be made effective on trade date April 20, 2009.
