Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended ("Act"), and section §40.6(d) of the regulations promulgated by the Commodity Futures Trading Commission (the "Commission") under the Act (the "Regulations"), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. ("Nadex", the "Exchange") hereby provides notice that it has added additional strike levels in its Daily and Weekly Gold and Silver Binary Contracts on trade date April 15, 2013 due to volitility in the underlying market on that day. Nadex returned to its regular listing schedule for its Daily Gold and Silver Binary Contracts on April 16, 2013. Nadex plans to return to its regular listing schedule for its Weekly Gold and Silver Binary Contracts on trade date April 22, 2013.

New strikes created on trade date April 15, 2013 are set forth in Exhibit A.

Nadex hereby certifies that the additions contained herein comply with the Act, as amended, and the Commission Regulations adopted thereunder.
