Dear Mr. Stawick:

The New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying an amendment to Supplement No. 2, "Licensed Warehouses for Aluminum" for the Aluminum Futures contract. The amendment is intended to delist Cottonwood Distribution Services, Inc. as an Exchange Licensed Warehouse for Aluminum.

The Exchange has been notified that Cottonwood Distribution Services, Inc. was merged into Stellar Distribution Services, Inc. and no longer exists as an entity. All material previously stored in the facility was removed as of December 2008. The Delivery Point Agreement between Cottonwood Distribution Services, Inc. and the Exchange expired on March 23, 2009.

Pursuant to Section 5c(c) of the Commodity Exchange Act ("Act") and CFTC Rule 40.6, the Exchange hereby certifies that the attached rule amendment complies with the Act, including regulations under the Act. This amendment will go into effect on Wednesday, April 22, 2009.
