The Board of Trade of the City of Chicago, Inc. ("CBOT" or "Exchange") hereby notifies the Commodity Futures Trading Commission of an amendment to Chapter 7 in the Interpretations & Special Notices Relating to Chapter 7 section of the CBOT Rulebook. The Exchange has been notified that "Country Star Co-Op Inc.," a regular firm for the delivery of Wheat, has changed its name to "Sunrise Cooperative." The change is a result of a merger of the two organizations.

The change is attached, with additions underscored and deletions lined-out. The amendment will be made effective immediately.
