Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended ("Act"), and section §40.6(d)(iv) of the regulations promulgated by the Commodity Futures Trading Commission (the "Commission") under the Act (the "Regulations"), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. ("Nadex", the "Exchange") hereby provides notice that it has added additional strike levels in its Daily Germany 30, US SmallCap 2000, US Tech 100, and Wall St 30 Binary Contracts on a discretionary basis for trade date April 23, 2012. Nadex returned to its regular listing schedule for these contracts on April 24, 2012. New strikes created on trade date April 23, 2012 are set forth in Exhibit A.
