**Re: Rule Certification. New York Mercantile Exchange, Inc. Submission #08.60: Notification of Amendments to Supplement No. 4, "Approved Carriers for Gold", NYMEX Chapter 90, Supplement No. 3, "Official List of Approved Carriers for Platinum", and NYMEX Chapter 100, Supplement No. 3, "Official List of Approved Carriers for Palladium".**

Dear Mr. Stawick:

The New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying the following amendments to Supplement No. 4: "Approved Carriers for Gold", NYMEX Chapter 90, Supplement No. 3, "Official List of Approved Carriers for Platinum", and NYMEX Chapter 100, Supplement No. 3, "Official List of Approved Carriers for Palladium". The amendments remove AT Systems Atlantic, Inc. from the aforementioned Supplements, and replace it with Garda CL Atlantic, Inc. In addition, the amendments remove Coin Devices Corporation ("CDC") from Supplement No. 4, "Approved Carriers for Gold".

These amendments reflect a name change resulting from the acquisition of ATI Systems, the parent company of AT Systems Atlantic, Inc., by Garda USA, Inc., in April 2007. Following the acquisition, the name "AT Systems Atlantic, Inc." was changed to "Garda CL Atlantic, Inc." Additionally, Supplement No. 4, "Approved Carriers for Gold", is being amended to reflect the delisting of CDC which no longer provides transportation services.

Pursuant to Section 5c(c) of the Commodity Exchange Act ("Act") and CFTC Rule 40.6, the Exchange hereby certifies that the attached rule amendments comply with the Act, including regulations under the Act. These changes will be made effective on May 19, 2008.
