Previously, pursuant to Submission No. 12-153 dated May 24, 2012, the Board of trade of the City of Chicago, Inc. ("CBOT" or the "Exchange") notified the Commodity Futures Trading Commission ("Commission") of the implementation of the CBOT Oat Futures Market Making Program ("Program").

In this letter, the Exchange is providing the Commission with certain additional information related to the incentives and obligations under the Program. The additional supplemental information is provided in Appendix A, for which a request for confidential treatment is being simultaneously submitted to the Commission. A copy of that request for confidential treatment is included with this supplemental filing.

CBOT certifies that the Program complies with the Commodity Exchange Act and the regulations thereunder. A concise explanation and analysis of the operation, purpose and effect of the Program was provided in Submission No. 12-153. There were no substantive opposing views to this Program.

By e-mail dated today, May 24, 2012, the Board of trade of the City of Chicago, Inc. ("CBOT") submitted a supplemental rule certification filing (submission No. 12-153S) to the Commodity Futures Trading Commission (the "Commission"). This supplemental filing includes an appendix ("Appendix A"), which is attached.

Pursuant to Sections 8 and 8(a) of the Commodity Exchange Act ("CEA"), as amended, and Commission Regulation 145.9(d), CBOT requests confidential treatment of Appendix A on the grounds that Appendix A contains confidential commercial information of the submitter (CBOT). A detailed written justification for this request is attached hereto as Exhibit 1. Pursuant to Commission Regulation 145.9(d)(5), CBOT requests that confidential treatment be maintained for Appendix A until further notice from CBOT. We also request that the Commission notify the undersigned immediately after receiving any FOIA request for said Appendix A or any other court order, subpoena or summons for same. Finally, we request that we be notified in the event the Commission intends to disclose such Appendix A to Congress or to any other governmental agency or unit pursuant to Section 8 of the CEA. CBOT does not waive its notification rights under Section 8(f) of the CEA with respect to any subpoena or summons for such Appendix A.
