Dear Mr. Stawick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (“Act”), and section §40.6(d)(2)(iv) of the regulations promulgated by the Commodity Futures Trading Commission (the “Commission”) under the Act (the “Regulations”), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. (“Nadex”, the “Exchange”) hereby provides notice that it has added additional strike levels in its Daily US Tech 100 and Wall Street 30 Binary Contracts for trade date May 30, 2012. Nadex returned to its regular listing schedule for these contracts on May 31, 2012.

Additionally, Nadex added strike levels in its Daily US Tech 100, Wall Street 30, US 500, US 2000, Germany 30, and Gold Binary Contracts on trade date June 1, 2012. Nadex plans to return to its regular listing schedule for these contracts on June 4, 2012.

New strikes created on trade dates May 30, 2012 and June 1, 2012 are set forth in Exhibit A.

Nadex hereby certifies that the additions contained herein comply with the Act, as amended, and the Commission Regulations adopted thereunder.
