Dear Mr. Stawick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (“Act”), and section §40.6(d)(2)(iv) of the regulations promulgated by the Commodity Futures Trading Commission (the “Commission”) under the Act (the “Regulations”), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. (“Nadex”, the “Exchange”) hereby provides notice that it has added additional strike levels in its Daily Silver, US Tech 100, Wall St 30, US 500, and US SmallCap 2000 Binary Contracts for Trade Date June 6, 2012. Nadex returned to its regular listing schedule for these contracts on June 7, 2012.

Additionally, Nadex added strike levels in its Daily Gold Binary Contracts on trade date June 7, 2012. Nadex returned to its regular listing schedule for these contracts on June 8, 2012.

New strikes created on trade dates June 6 and 7, 2012 are set forth in Exhibit A.
