The New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying amendments to the Position Limit, Position Accountability and Reportable Level Table located in the Interpretations and Special Notices Section of Chapter 5 of the NYMEX Rulebook in order to decrease the expiration month position limit of the Mont Belvieu Spot Ethylene In-Well (PCW) Futures contract from its current 1,500 contract units to 1,000 contract units. The Exchange determined to decrease the expiration month position limit for the contract as a result of a review of the current physical supply of ethylene at Mont Belvieu.
