Dear Mr. Stawick:

Previously, by letter dated June 11, 2009 (submission #09-108), the New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") notified the Commodity Futures Trading Commission ("CFTC" or "Commission") that it was self-certifying amendments to Chapter 9A, Appendix A, in connection with the launch of six (6) new petroleum swap futures contracts. This letter is intended to revise submission #09-108 in order to correct inadvertent, clerical errors to the all month/any one month accountability levels (NYMEX Rule 9A.26) and expiration month position limits (NYMEX Rule 9A.27) of three (3) of the petroleum swap contracts. These revisions are included herewith in Appendix A. All other contents of the submission #09-108 remain unchanged.

Pursuant to Section 5c(c) of the Commodity Exchange Act ("Act") and CFTC Rule 40.6, the Exchange hereby certifies that the attached rule amendments comply with the Act, including regulations under the Act. These changes will be made effective on trade date June 22, 2009.
