Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (“Act”), and section §40.6(d) of the regulations promulgated by the Commodity Futures Trading Commission (the “Commission”) under the Act (the “Regulations”), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. (“Nadex”, the “Exchange”) hereby provides notice that it has added additional strike levels in its Daily Wall Street 30, US Tech 100, US 500, US SmallCap 2000, Germany 30, FTSE 100<sup>®</sup>, Gold, and Silver Binary Contracts for trade date June 20, 2013. Nadex returned to its regular listing Schedule for these contracts on June 21, 2013.

New strikes created on trade date June 20, 2013 are set forth in Exhibit A.
