Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended ("Act"), and section §40.6(d)(2)(iv) of the regulations promulgated by the Commodity Futures Trading Commission (the "Commission") under the Act (the "Regulations"), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. ("Nadex", the "Exchange") hereby provides notice that it has added additional strike levels in its Weekly Corn Binary Contracts on trade date June 19, 2012. Nadex plans to return to its regular listing schedule for these contracts on June 25, 2012. Nadex has also added additional strike levels in its Daily Gold, Silver, US Tech 100, Wall Street 30, US 500 and US SmallCap 2000 Binary Contracts for Trade Date June 21, 2012. Nadex returned to its regular listing schedule for these contracts on June 22, 2012.

New strikes created on trade dates June 19 and 21, 2012 are set forth in Exhibit A.
