Dear Mr. Stawick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (“Act”), and section §40.6(d)(2)(iv) of the regulations promulgated by the Commodity Futures Trading Commission (the “Commission”) under the Act (the “Regulations”), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. (“Nadex”, the “Exchange”) hereby provides notice that it has added additional strike levels in its Daily US Tech 100 and Wall Street 30 Binary Contracts for trade date June 28, 2012. Nadex returned to its regular listing Schedule for these contracts on June 29, 2012. Nadex also added additional strike levels in its Daily AUD/USD, EUR/USD, GBP/USD, USD/CAD, USD/CHF, US Tech 100, Wall Street 30, US 500, US SmallCap 2000, Germany 30, Gold, Silver, and Copper Binary Contracts for trade date June 29, 2012. Nadex plans to return to its regular listing schedule for these contracts on July 2, 2012.

New strikes created on trade dates June 28 and 29, 2012 are set forth in Exhibit A.

Nadex hereby certifies that the additions contained herein comply with the Act, as amended, and the Commission Regulations adopted thereunder.
