The Commodity Exchange, Inc. ("COMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying an amendment to Copper Supplement No. 3, "Licensed Weighmasters for Copper" in order to update and maintain a current and accurate listing of Licensed Weighmasters of the Exchange's Copper futures contract and their current contact information.

The proposed amendments, presented below, (1) eliminate those currently listed Licensed Weighmasters who no longer provide the services of a Licensed Weighmaster, and (2) provide updated contact information for those currently listed Licensed Weighmasters.
