Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (“Act”), and section §40.6(d)(2)(iv) of the regulations promulgated by the Commodity Futures Trading Commission (the “Commission”) under the Act (the “Regulations”), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. (“Nadex”, the “Exchange”) hereby provides notice that it has added additional strike levels in its Daily Germany 30 and Wall St 30 Binary contracts for trade date August 2, 2012. Nadex returned for its regular listing schedule for these contracts on August 3, 2012. Additionally, Nadex added additional strike levels in its Daily EUR/USD, US Tech 100, Wall St 30, US 500, US SmallCap 2000, and Germany 30 Binary Contracts for Trade Date August 3, 2012. Nadex plans to return to its regular listing schedule for these contracts on August 6, 2012.

New strikes created on trade dates August 2 and 3, 2012 are set forth in Exhibit A.
