**Re: CFTC Regulation 40.2(a) Certification: Notification of New Product Listing of the PJM Daily Load Forecast Futures Contract and Related Rule Amendments  
NYMEX Submission #13-332**

Dear Ms. Jurgens:

The New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying the listing of the PJM Daily Load Forecast Futures contract for trading on the NYMEX trading floor and CME Globex and for submission for clearing through CME ClearPort beginning at 6:00 p.m. on Sunday August 25, 2013, for trade date Monday, August 26, 2013.

Pursuant to Commission Regulation 40.6(a), NYMEX is separately self-certifying block trading minimum thresholds of two (2) contracts for PJM Daily Load Forecast Futures in CBOT/NYMEX/COMEX Submission No. 13-316. Block transactions are governed by Rule 526.

The contract specifications are as follows:

<b>Contract Size</b>	The unit of trading shall be the \$0.10 multiplied by the maximum hourly load, rounded to nearest whole megawatt, in the entire PJM system for the specified operating day that is the contract day. Hourly load is computed as the sum of the regional load values reported by PJM.
<b>Last Trading Day</b>	Trading shall cease on the business day following the PJM operating day that is the calendar day.
<b>Minimum Price Fluctuation</b>	The minimum fluctuation shall be \$0.10.
<b>First Listed Day</b>	August 26, 2013
<b>Listing Schedule</b>	<u>CME Globex, CME ClearPort, and Open Outcry</u> : Current day and the subsequent six calendar days.

The Exchange is also notifying the CFTC that it is self-certifying the insertion of the terms and conditions for the contract into the Position Limit, Position Accountability and Reportable Level Table and Header Notes located in the Interpretations and Special Notices Section of Chapter 5 of the NYMEX Rulebook in relation to the listing of the new contract, as set forth in Appendix B. The terms and conditions establish the all month/any one month accountability levels, diminishing balances, expiration month position limit, reportable level and aggregation allocation for the new contract. In addition, the Exchange is self-certifying the insertion of the non-reviewable ranges (“NRR”) for the futures contract into Rule 588.H, as set forth in Appendix C.

Exchange business staff responsible for the new products and the Exchange Legal Department collectively reviewed the designated contract market core principles (“Core Principles”) as set forth in the Commodity Exchange Act (the “Act” or “CEA”). During the review, Exchange staff identified that the new products may have some bearing on the following Core Principles:

**Compliance with Rules:** Trading in the contract will be subject to the rules in Rulebook Chapter 4 which includes prohibitions against fraudulent, noncompetitive, unfair and abusive practices. Additionally, trading in this futures contract will also be subject to the full panoply of trade practice rules, the majority of which are contained in Chapter 5 and Chapter 8 of the Rulebook. As with all products listed for trading on one of CME Group’s designated contract markets, activity in the new

product will be subject to extensive monitoring and surveillance by CME Group's Market Regulation Department. The Market Regulation Department has the authority to exercise its investigatory and enforcement power where potential rule violations are identified.

Contracts not Readily Subject to Manipulation: The PJM Daily Load Forecast Futures contract is not readily subject to manipulation due to fact that load is not easily affected as individuals and businesses consume electricity largely based on need. Furthermore, PJM, along with Monitoring Analytics (the independent market monitor) and the Federal Energy Regulatory Commission, monitor the competitiveness of the hourly auctions used to price electricity in the day-ahead and real-time power markets.

Prevention of Market Disruption: Trading in the PJM Daily Load Forecast Futures contract will be subject to the NYMEX rules ("Rulebook") Chapters 4 and 7, which include prohibitions against fraudulent, noncompetitive, unfair and abusive practices. Additionally, trading in the futures contract will be subject to the full panoply of trade practice rules, the majority of which are contained in Chapter 5 and Chapter 8 of the Rulebook. As with all products listed for trading on one of CME Group's designated contract markets, activity in the PJM Daily Load Forecast Futures contract will be subject to monitoring and surveillance by CME Group's Market Regulation Department. The Market Regulation Department has the authority to exercise its investigatory and enforcement power where potential rule violations are identified.

Position Limitations or Accountability: The spot-month speculative position limit for the contract is set at less than the threshold of 25% of the deliverable supply in the underlying market.

Availability of General Information: The Exchange will publish information on the contract's specifications on its website.

Daily Publication of Trading Information: Trading volume, open interest, and price information will be published daily on the Exchange's website and via quote vendors.

Financial Integrity of Contracts: This contract will be cleared by the Clearing House of the Chicago Mercantile Exchange, Inc., which is a registered derivatives clearing organization with the Commission and is subject to all Commission regulations related thereto.

Execution of Transactions: The new contract will be listed for trading on CME Globex and the NYMEX trading floor and for clearing through the CME ClearPort platform. The CME ClearPort platform provides a competitive, open and efficient mechanism for novating transactions that are competitively executed by brokers. The CME Globex electronic trading platform provides for a competitive and open execution of transactions due to its advanced functionality, high reliability and global connectivity. Establishing a non-reviewable trading range for Globex trades in the product facilitates price discovery in the product by encouraging narrow bid/ask spreads. In addition, the NYMEX trading floor continues to be available as a trading venue and provide for competitive and open execution of transactions.

Trade Information: All required trade information is included in the audit trail and is sufficient for the Market Regulation Department to monitor for market abuse.

Protection of Market Participants: Rulebook Chapters 4 and 5 contain multiple prohibitions precluding intermediaries from disadvantaging their customers. These rules apply to trading on all of the Exchange's competitive trading venues and will be applicable to transactions in the PJM Daily Load Forecast Futures contract.

Disciplinary Procedures: Chapter 4 of the Rulebook contains provisions that allow the Exchange to discipline, suspend or expel members or market participants that violate the Rulebook. Trading in the PJM Daily Load Forecast Futures contract will be subject to Chapter 4, and the Market Regulation Department has the authority to exercise its enforcement power in the event rule violations in this contract are identified.

Dispute Resolution: Disputes with respect to trading in the PJM Daily Load Forecast Futures contract will be subject to the arbitration provisions set forth in Chapter 6 of the Rulebook. Chapter 6 allows all nonmembers to submit a claim for financial losses resulting from transactions on the Exchange to arbitration. A member named as a respondent in a claim submitted by a nonmember is required to

participate in the arbitration pursuant to Chapter 6. Additionally, the Exchange requires that members resolve all disputes concerning transactions on the Exchange via arbitration.

Pursuant to Section 5c(c) of the Act and CFTC Regulation 40.2, the Exchange hereby certifies that the PJM Daily Load Forecast Futures contract complies with the Act and regulations thereunder. There were no substantive opposing views to this proposal. A description of the underlying cash market and deliverable supply analysis for the new product is attached hereto as Appendix D.

## APPENDIX A

### Chapter 181 PJM Daily Load Forecast Futures

#### 181100. SCOPE OF CHAPTER

The provisions of these rules shall apply to all contracts bought or sold on the Exchange for cash settlement based on the Floating Price. The procedures for trading, clearing and cash settlement of this contract, and any other matters not specifically covered herein shall be governed by the general rules of the Exchange.

#### 181101. CONTRACT SPECIFICATIONS

The Floating Price shall be equal to \$0.10 multiplied by the actual maximum hourly load for the entire PJM Interconnection LLC ("PJM") system, rounded to the closest whole megawatt for the operating day that is the contract day. PJM reports actual hourly load data on a regional basis. Actual regional loads are published on the PJM website under the "Markets & Operations" tab, "Energy Market" subsection, "Real-Time Energy Market" link, and finally the link entitled "Hourly Load Data." The actual PJM system-wide load for a given hour on a particular operating day is calculated as the sum of the actual loads for that hour which are reported for the various PJM regions. The Floating price will utilize the maximum value of the operating day's system-wide hourly loads, rounded to the closest whole megawatt, as calculated using the procedure outlined in the previous sentence. For the purpose of rounding the hourly load, any value with a fraction of a megawatt at or greater than 0.5 will be rounded up to the nearest whole megawatt. Any value with a fraction of a megawatt less than 0.5 will be rounded down to the nearest whole megawatt.

#### 181102. TRADING SPECIFICATIONS

The number of days open for trading at a given time shall be determined by the Exchange.

##### 181102.A. Trading Schedule

The hours of trading for this contract shall be determined by the Exchange.

##### 181102.B. Trading Unit

The unit of trading shall be \$0.10 multiplied by the maximum hourly load, rounded to nearest whole megawatt, in the entire PJM system, as posted by PJM for the specified operating day that is the contract day.

##### 181102.C. Price Increments

Bids and offers shall be quoted in terms of the maximum hourly load (megawatts) in the entire PJM system. The minimum fluctuation of the futures contract shall be one megawatt hour. Prices shall be quoted in U.S. dollars and cents. The minimum price fluctuation shall be \$0.10 per contract.

##### 181102.D. Position Limits and Position Accountability

The applicable position limits and/or accountability levels, in addition to the reportable levels, are set forth in the Position Limit, Position Accountability and Reportable Level Table in the Interpretations & Special Notices Section of Chapter 5.

A Person seeking an exemption from position limits for bona fide commercial purposes shall apply to the Market Regulation Department on forms provided by the Exchange, and the Market Regulation Department may grant qualified exemptions in its sole discretion.

Refer to Rule 559 for requirements concerning the aggregation of positions and allowable exemptions from the specified position limits.

##### 181102.E. Termination of Trading

Trading shall cease on the business day following the PJM operating day that is the calendar day.

#### 181103. FINAL SETTLEMENT

Final settlement under the contract shall be by cash settlement. The final settlement price will be the Floating Price calculated for the specified contract day.

#### 181104. FINAL PAYMENT

Final payment shall be made five (5) business days following termination of trading in the contract. For payment purposes, the Floating Price available at the time of final payment will be considered final and no further revisions will be made by the Exchange.

## APPENDIX D

# Deliverable Supply Analysis: PJM System-Wide Maximum Hourly Load

### Proposed Contract

The proposed futures contract prices the difference between the forecasted and actual maximum hourly load in the entire PJM system during the specified operating day. Each megawatt is worth \$0.10. If a trader believes that the actual maximum hourly load will come in at less than the forecasted value, then the trader will go short the futures contract. So, if the forecasted value is 60,000 megawatts (MW) and the actual value turns out to be 50,000 MW, the difference will result in the trader making a \$1,000 profit (i.e., 10,000 MW multiplied by \$0.10). It is anticipated that market participants will use the subject load contract to hedge the load in all hours of the operating day.

### Background on PJM

PJM is an independent regional transmission organization (RTO) that plays a vital role in the U.S. electric system by providing its members with opportunities for buying and selling power, arranging transmission service, and allowing the use of larger and more efficient generating units. PJM coordinates the generation and movement of electricity in all or parts of Delaware, Illinois, Indiana, Kentucky, Maryland, Michigan, New Jersey, North Carolina, Ohio, Pennsylvania, Tennessee, Virginia, West Virginia, and the District of Columbia. Ultimately, PJM ensures electric reliability for more than 60 million people. In 1997, PJM began operating the nation's first regional, bid-based, hourly energy market. PJM acts as a neutral, independent party as it operates the competitive wholesale electricity market and manages the high-voltage electricity grid. PJM's long-term regional planning process provides a broad, interstate perspective that identifies the most effective and cost-efficient improvements to the grid to ensure reliability and economic benefits on a system-wide basis.

### Market Competitiveness

Independent system operators (ISO) and RTO markets manage the generation and transmission of electricity within their respective service areas. ISOs/RTOs are highly competitive and were established following Federal Energy Regulatory Commission (FERC) orders. FERC Order No. 888 identified barriers to competitive wholesale electricity markets and required those barriers to be removed. FERC Order No. 889 established open access to system information. FERC Order No. 2000 provided the framework for the formation of ISO/RTO markets. Under FERC authority, most U.S. ISOs/RTOs, such as PJM, Midcontinent ISO (formerly Midwest ISO), New York ISO, and ISO New England, operate and monitor their respective market to ensure the competitiveness and reliability of the electricity system.

ISOs/RTOs also are monitored by the North American Electric Reliability Corporation (NERC), a non-profit organization made up of stakeholders responsible for developing reliability standards and ensuring compliance with those standards. NERC has various committees, sub-committees, task forces, and working groups that investigate and analyze system disruptions in order to prevent market manipulation.

Besides governmental and industry organizations, each ISO/RTO is monitored by an independent market monitor. Each market monitor regularly evaluates the competitiveness of the ISO/RTO market(s) for which it is responsible for, recommends improvements plans, and reviews the implementation of those plans. In the case of PJM, the market monitor is Monitoring Analytics.<sup>1</sup> Every market monitor, including Monitoring Analytics, publishes quarterly and annual market reports to raise public awareness of the state of the respective markets.

### Day-ahead vs. Real-Time Market

PJM offers two basic energy markets for electricity participants: a real-time (or spot) market and a day-ahead market. The real-time and day-ahead markets are interrelated as the day-ahead market is a forward market for the real-time delivery of power during the

following day. Specifically, market participants use the day-ahead market to price power that will flow during a particular hour on the following day. The real-time market prices electricity that flows the same day during a particular hour. Both the day-ahead and the real-time markets utilize a competitive auction process developed by the stakeholders from both the generation and load sides. Market-clearing prices, known as locational marginal prices (LMPs), are determined for each hour; LMPs reflect dynamic and competitive pricing. Moreover, the LMPs are published publicly by the ISOs/RTOs on a timely basis to ensure competitiveness and transparency. Real-time generation and load may differ from forecasted generation and load indicated in the day-ahead market.

### Deliverable Supply

Electricity load is the power that is extracted from an ISO's/RTO's electrical grid, essentially representing power demand. The basis of the subject futures contract is the actual maximum hourly load in the entire PJM system during a specified operating day.

As part of its activities, PJM forecasts (and updates) on an hourly basis future electricity load for each one-hour period (e.g., between 1:01 pm and 2:00 pm) during the remainder of the current calendar day and for the subsequent six calendar days. This analysis is needed to ensure that generation sources are available and ready to serve demand. As each hour passes and power is generated and consumed, PJM reports the actual load realized during that hour. The final hourly load is calculated and posted when all transaction information has been confirmed with market participants and the external control areas. PJM reports load data for the following regions: PJM Mid-Atlantic Region; Allegheny Power; Commonwealth Edison Company; Dayton Power & Light Company; American Electric Power; Dunquesne Light Company; Dominion Virginia Power; American Transmission Systems, Inc.; Duke Energy Ohio & Kentucky; and East Kentucky Power Cooperative. Total system load each hour is the sum of the hourly loads across the various PJM regions. This information is publically available on PJM's website.<sup>2</sup> Forecasted hourly loads for the remainder of the current day and the subsequent six calendar days are available HTML format.<sup>3</sup> Note that a given seven-day forecast is replaced when the next seven-day forecast is determined and published.

Historical daily maximum hourly load values realized in the entire PJM system were obtained from the ISO itself. The maximum daily load data gathered by NYMEX staff covered the three-year period from July 3, 2010, through July 2, 2013 (see Attachment A). Over the three-year period, the maximum hourly load in a given day in the entire PJM system ranged from 67,601 MW to 978,054 MW, with the average being 100,519 MW. The low and average maximum load values for each yearly block (July to July) were similar to those for the entire three-year period. The peak maximum loads, in contrast, varied significantly, with the largest maximum hourly load in the July 2012-July 2013 timeframe being approximately 825,000 MW higher than in the other two one-year periods.

In terms of pricing, the simple average of the daily average real-time LMP for the PJM system between July 3, 2010, and July 2, 2013, was \$39.16 per MW.<sup>4</sup>

PJM, like other ISOs and RTOs, operate day-ahead and real-time markets in order to ensure that enough power is produced to meet demand. As noted above, load is the amount of electricity withdrawn from the power grid, essentially representing demand. Exchange staff believes that it would be difficult to manipulate load. Generally, residential and industrial consumers consume electricity based on need. However, there are certain times of the year when the electrical grid is stressed. In PJM, summer months reflect peak demand for power, typically to run air conditioners. In order to maintain the reliability of the power system, PJM and other ISOs/RTOs utilize demand response programs to reduce stress on the grid. Participation in PJM's demand response program is voluntary and is activated when load and/or market prices become too high or there is a system emergency.<sup>5</sup> While demand response impacts actual load, the effect is not surprising since affected entities agreed to participate in the program. Moreover, the triggering events likely are not the result of manipulation in the hourly auctions. In this regard, PJM monitors the competitiveness of the hourly auctions, which is verified by Monitoring Analytics, the independent market monitor. Triggering events, in contrast, are likely the result of excessively high demand or threats to the reliability of the electrical grid.

For traditional cash-settled electricity contracts listed for trading by NYMEX, the terms and conditions specify contract sizes in terms of megawatts. For example, a peak-hour monthly contract may have a size of 80 MW. In order to determine the spot-month speculative position limit for such a contract, the contract size would be compared to the deliverable supply of power in the specified hub or utility zone. Recently, the Exchange has used average actual load as a measure of deliverable supply. So, for a traditional power futures contract, a small block of power is compared to the overall volume of available electricity. By way of example, if the total monthly load is 8,000,000 MWh and the contract size is 80 MW, the deliverable supply is equivalent to 100,000 contracts where one contract equals 0.001% of the deliverable supply.

The subject load forecast futures contract is similar to the NYMEX's ERCOT Daily Load Forecast Futures contract. Unlike NYMEX's traditional power contracts which specify a quantity for the contract size, the subject contract's size is the actual maximum hourly load in the entire PJM system for the specified operating day, multiplied by a price deflator. Specifically, each megawatt of actual maximum hourly load is worth \$0.10. Thus, the price of the contract also is the contract trading unit.

It is anticipated that market participants will use the subject futures contract to hedge the value of load in the entire operating day. In order to be consistent with the unit of trading in the deliverable supply analysis, the deliverable supply should not be a quantity. Instead, in this particular case, the deliverable supply should be the market value of the load during the operating day. For example, if the load in a given day is 700,000 megawatt hours (MWh), the value of that daily load would be \$28 million, assuming an average hourly LMP of \$40 per MW. If the actual maximum hourly load during the operating day is 50,000 MW, the contract's value would represent 0.018% of the daily load's value.

To get a more accurate assessment of deliverable supply, daily total load in the entire PJM system between July 3, 2010 and July 2, 2013, was multiplied by the average daily LMP obtained from NRGSTREAM and PJM (Attachment B). The value of the daily loads during that period ranged from \$17.37 million to \$472.67 million. In order to place the deliverable supply on a contract-equivalent basis, the Exchange utilized the average value of daily load (\$83.36 million) and the average maximum hourly load (100,519 MW) multiplied by \$0.10. Thus, the minimum deliverable supply is estimated to be equivalent to 8,293 contracts.

Speculative position limits are used to restrict the size of speculators' positions, thus reducing the incentive to manipulate the final settlement price through abnormal changes in the reported maximum load. In setting the speculative position limits, the

Commission recommends that the spot-month speculative position limit should be no greater than 25% of the deliverable supply. The proposed spot-month speculative is 2,000 contracts, which is 24% of the estimated deliverable supply.
