Ladies and Gentlemen:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (“Act”), and Section 40.6 of the regulations promulgated by the Commodity Futures Trading Commission under the Act, the NASDAQ OMX Futures Exchange, Inc. (“NFX” or “Exchange”) hereby submits the attached Notice to Members regarding Timber Hill LLC as a market maker in foreign currency futures contracts for another year.

On August 22, 2008 NFX (then known as the Philadelphia Board of Trade or “PBOT”) filed SR-PBOT-2008-12, the Market Maker Agreement between Timber Hill LLC and NFX dated June 23, 2008, pursuant to which Timber Hill LLC had agreed to act as a market maker in one or more NFX foreign currency futures contracts pursuant to NFX Rule E10. That submission was made pursuant to NFX’s original submission dated June 18, 2008 and provided an additional document related to that submission. The agreement expired on September 23, 2008, but was extended for another year.

NFX and Timber Hill have now entered into an agreement on the same terms and conditions for another one year term, beginning on September 22, 2009. The terms and conditions of the agreement are identical to those of the agreement that expires September 23, 2009, except for the change to effective date and the term of the agreement. The Notice to Members will be issued on Tuesday, September 22, 2009.

There were no opposing views among the NFX's Board of Directors, members or market participants. NFX hereby certifies that the market maker agreement and the attached Notice to Members comply with the Commodity Exchange Act and regulations thereunder.
