The Commodity Exchange, Inc. ("COMEX" or the "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") of an amendment to Supplement No. 2, "Licensed Warehouses for Copper" of the Grade 1 Copper Futures Contract. Arizona Commodity Storage, Inc., an Exchange Licensed Warehouse for the storage of Copper, has notified the Exchange that its facility located at 850 East Teton, Tucson, AZ, is no longer available for the storage of copper deliverable against the Exchange's Grade 1 Copper Futures contract. Copper has not been stored at the aforementioned location since prior to 2007. The amendment delists the warehouse operated by Arizona Commodity Storage, Inc., located at 850 East Teton, Tucson, AZ as an Exchange Licensed Warehouse for Copper.

Pursuant to Section 5c(c) of the Commodity Exchange Act ("Act") and CFTC Rule 40.6, the Exchange hereby certifies that the attached rule amendment complies with the Act, including regulations under the Act. This amendment will go into effect on Wednesday September 23, 2009.
