
RE: Rule Certification: Nadex® Amends its Holiday Schedule for Korea 200 contracts for the October 2, 2009 Korean Holiday – Submission pursuant to Commission Regulation §40.6(a)

Dear Mr. Stawick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (the Act"), and §40.6(a) of the regulations promulgated by the Commodity Futures Trading Commission (the "Commission") under the Act, North American Derivatives Exchange, Inc. ("Nadex") hereby submits to the Commission its intent to amend its trading hours and listing schedule for the Korea 200 contracts for the October 2, 2009 Korean Holiday.

For the Korean Holiday on October 2, 2009, Nadex will observe the following business hours:

- On trade date Thursday, October 1, 2009, the Exchange will observe regular exchange hours. Contract specific trading hours on October 1, 2009 for the Korea 200 Contracts are as follows:
 - All daily Korea 200 contracts will be available for trading during the evening session from 8:00 pm ET on Wednesday, September 30, 2009 and will close at their regular times.
 - · All Weekly Binary Korea 200 contracts listed on Sunday, September 27, 2009 at 8:00 pm ET will have an expiration and settlement date of Thursday, October 1, 2009 and will close at 2:05 am ET.
- On Friday, October 2, 2009, the Exchange will observe regular exchange hours. No Korea 200 contracts will be offered.





No contracts that have open interest will be affected by these amendments.

Nadex intends to implement these rule amendments provided for herein effective at the start of business on September 28, 2009.

No substantive opposing views were expressed to Nadex with respect to any of these actions.

Nadex hereby certifies that the revisions contained herein, comply with the Act and the Commission Regulations adopted thereunder.
