RE: Rule Certification: Nadex® Amends its Holiday Schedule for Korea 200 contracts for the October 2, 2009 Korean Holiday – Submission pursuant to Commission Regulation §40.6(a)

Dear Mr. Stawick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (the Act"), and §40.6(a) of the regulations promulgated by the Commodity Futures Trading Commission (the "Commission") under the Act, Nadex, Inc. ("Nadex") hereby submits to the Commission its intent to amend its trading hours and listing schedule for the Korea 200 contracts for the October 2, 2009 Korean Holiday.

For the Korean Holiday on October 2, 2009, Nadex will observe the following business hours:

- On Thursday, October 1, 2009, the Exchange will observe regular exchange hours. Contract specific trading hours on October 1, 2009 for the Korea 200 Contracts are as follows:
  - · All daily contracts will be available for trading at 8:00 pm ET and will close at their regular times.
  - · All Weekly Binary contracts offered on this date will have an expiration and settlement date of Thursday, October 1, 2009 and will close at 2:05 am ET.
- On Friday, October 2, 2009, the Exchange will observe regular exchange hours. No Korea 200 contracts will be offered during the evening session from 8:00 pm ET to 2:05 am ET.



• On Monday, October 5, 2009, the Exchange will observe regular exchange hours.

No substantive opposing views were expressed to Nadex with respect to any of these actions.

Nadex hereby certifies that the revisions contained herein, comply with the Act and the Commission Regulations adopted thereunder.
