The New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying administrative amendments to NYMEX Chapter 5, Position Limit, Position Accountability and Reportable Level Table in order to revise the titles of seven (7) natural gas contracts such that the titles cited in NYMEX Chapter 5 conform with the actual titles of those chapters. The Exchange amended the titles of the seven natural gas contracts pursuant to a self-certification (Submission #09-13) filed with the Commission on February 5, 2009.

Pursuant to Section 5c(c) of the Commodity Exchange Act ("Act") and CFTC Rule 40.6, the Exchange hereby certifies that the attached rule amendments comply with the Act, including regulations under the Act. These changes will be made effective on trade date October 1, 2009.
