RE: Modifications (Renewal) to CME E-mini Equity Options Spread Incentive Program CME Submission No. 12-325

Dear Ms. Warfield:

Chicago Mercantile Exchange Inc. ("CME" or the "Exchange") hereby notifies the Commodity Futures Trading Commission ("Commission") that it plans to renew the CME E-Mini Equity Options Spread Incentive Program ("Program"). The modifications to the Program will become effective on January 2, 2013.

Exhibit 1 sets forth the terms of the Program. Modifications to the Program are set forth below with additions underscored and deletions overstruck.

CME business staff responsible for the Program and the CME legal department collectively reviewed the designated contract market core principles ("Core Principles") as set forth in the Commodities Exchange Act ("CEA"). During the review, CME staff identified the following Core Principles as potentially being impacted; Prevention of Market Disruption, Execution of Transactions, Protection of Market Participants, and Compliance with Rules.

The Program's incentive structure does not incentivize manipulative trading or market abuse and does not impact the Exchange's ability to perform its trade practice and market surveillance obligations under the CEA. The Exchange's market regulation staff will nevertheless continue to monitor trading in the Program's products to prevent manipulative trading and market abuse. The incentives in the Program do not impact the Exchange's order execution. Participants in the Program will be selected by the Exchange's staff using criteria as further stated in Exhibit 1. Chapter 4 of the Exchange's rules includes prohibitions against fraudulent, non-competitive, unfair or abusive practices. The Program is subject to these rules.

CME certifies that the Program complies with the CEA and the regulations thereunder. There were no substantive opposing views to this Program.

EXHIBIT 1

CME E-MINI EQUITY OPTIONS SPREAD INCENTIVE PROGRAM

Program Purpose

The purpose of this Program is to incentivize Program participants to trade spread transactions in E-mini Equity option products on the CME Globex® Platform. The resulting increase in liquidity on the CME Globex® Platform benefits all participant segments in the market.

Product Scope

All spread transactions in CME E-mini Equity option products available for trading on the Globex® Platform ("Products").

Eligible Participants

There is no limit to the amount of participants that may participate in the Program. The following catagories of CME members and non-members are eligible to participate:

Individual Equity Members Clearing Members Rule 106.J Equity Member Firms Rule 106.I Members Rule 106.S Member Approved Funds Rule 106.D Lessees Rule 106.F Employees

Program Term

Start date is January 1, 2012. End date is December 31, 2012 December 31, 2013.

Hours

The incentives will apply to all trades made in the Products regardless of the execution time.

Program Incentives

Each participant shall be eligible for the following incentives:

<u>Fee Discounts</u>. All Program participants will receive Globex® execution fee discounts in the Products so that the Globex® execution fee charged equals \$0.125 per-side traded.

Monitoring and Termination of Status

The Exchange shall monitor participants' activity in the Products and retains the right to revoke Program participant status if it concludes from review that a Program participant no longer meets the eligibility requirements of the Program.
