**Re: Energy Contract Block Trade Sizes  
Submission Pursuant to Commission Regulation 40.6(a)**

Dear Ms. Warfield:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (the “CEA”) and Commission Regulation 40.6(a) ICE Futures U.S., Inc. (“IFUS” or “Exchange”) hereby submits amendments to the block trade minimum levels for certain Energy Futures and Options Contracts, attached hereto as Exhibit A. The amendments were requested by the Commission’s Division of Market Oversight to increase from 1 contract to 5 contracts the minimum block size for certain contracts. In addition, the Exchange is reducing the block minimum size of the PJM AEP Dayton Hub Day Ahead, LMP, Peak Daily (ADA) contract from 475 contracts to 50 contracts. The amendments will become effective on November 1, 2012.

The Exchange certifies that the amendments comply with the requirements of the CEA and the rules and regulations promulgated thereunder, specifically Core Principle 9, which permits transactions such as block trades to be executed away from the central limit order book in accordance with contract market rules submitted to the Commission, at levels specified by the Exchange.

No substantive opposing views were expressed to the amendments. The Exchange further certifies that, concurrent with this filing, a copy of this submission was posted on the Exchange’s website at (<https://www.theice.com/notices/RegulatoryFilings.shtml>).
