Re: Rule Certification. Commodity Exchange, Inc. Submission 10-237: Notification of Approved Amendment to Supplement No. 2, "Licensed Depositories and Weighmasters for Silver" of the Silver Futures Contract. - Brink's, Inc.

Dear Mr. Stawick:

The Commodity Exchange, Inc. ("COMEX" or "Exchange") hereby notifies the Commodity Futures Trading Commission ("CFTC" or "Commission") of an amendment to Supplement No. 2, "Licensed Depositories and Weighmasters for Silver" of the Silver Futures contract. The amendment lists Brink's, Inc. at its 580 Fifth Ave. location in New York, NY, as an Exchange Licensed Weighmaster for silver for the COMEX Silver futures contract.

APPLICATION SUMMARY OF REQUIREMENTS

The application submitted by Brink's, Inc. for its facility at 580 Fifth Ave., New York, NY to be a Licensed Weighmaster for silver for the Exchange's Silver Futures contract meets the requirements of the Exchange.

BACKGROUND AND APPLICATION REQUIREMENTS

The Brink's Company, which owns Brink's Inc., was founded as Brink's City Express in Chicago in 1859, and has been in operation for 150 years and is currently based in Richmond, Virginia. Starting as an armored transportation service, it evolved to expand its operations to include precious metals storage in the late 1990s. Brink's has been operating Licensed Depositories approved to store precious metals against the Exchanges' precious metals contracts for 10 years. Brink's international network operates about 875 facilities and services customers in over 50 countries and employs approximately 59,400 people.

Brink's has been a Licensed Weighmaster for the Exchange's Gold contract since its first storage approval in 2001. Over the years, Brink's has weighed silver, at customers' requests, to confirm the weight incised on the bar, and have stamped weights on non-COMEX eligible inventory (100 troy ounce bars, and non-approved brands). Firms including, but not limited to, JP Morgan, Prudential, and Heraeus have requested to utilize Brink's services for Weighmaster purposes. The vault management and staff at Brink's have been trained in the use of all of the equipment, and are well versed in the Exchange's procedures and Rules concerning Licensed Weighmaster status. The vault Brink's employs Mettler Toledo SG32001DR or KCC150 high precision self-calibrating balances. The scales for silver weigh to a tolerance of 1/100th of a troy ounce, and meet all of the Exchange's requirements. Brink's has a maintenance plan that includes semi-annual inspections and calibration tests by certified Mettler Toledo Technicians.

Brink's, Inc. has provided the Exchange with a current list of qualified vault personnel who are certified to be tasked to perform the duties of a Weighmaster as well as a list of rates and charges to perform such duties.

Pursuant to Section 5c(c) of the Commodity Exchange Act ("Act") and CFTC Rule 40.6, the Exchange hereby certifies that the attached amendment complies with the Act, including regulations under the Act. This amendment, which is attached with additions underscored, will become effective on Tuesday, November 2, 2010.
