Re: Amendments to Certain Exchange Fees
Submission Pursuant to Commission Regulation 40.5(a) and 40.6(a)

Dear Ms. Warfield:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (the "CEA") and Commission Regulation 40.6(a) ICE Futures U.S., Inc. ("IFUS" or "Exchange") hereby submits amendments to all Exchange license and renewal fees, cotton warehouse fees and the coffee grading fee, as described below. In addition, pursuant to Commission Regulation 40.5(a), the Exchange requests approval of amendments to the cotton certification fee and the eCOPs documentation fee, also described below.

Licensing Fees

Amendments to Resolution No. 1 of Chapter 7 will increase by \$100 the fee for license applications and annual renewals submitted for warehouses, samplers, weighmasters and graders, as set forth in Exhibit A. The amendments also eliminate dated references to license fees for Pulp, which is no longer listed by the Exchange.

Cotton Warehouse Inspection Fees

Exchange Rule 7.08 provides that warehouse operators bear all expenses incurred by the Exchange for any inspection of a store facility. Currently, the Exchange passes inspection charges on to warehouse operators for all commodities except cotton. The Exchange will now pass such inspection fees to cotton warehouse operators in accordance with Rule 7.08(f).

Coffee Grading Fee

The amendments to Appendix II (l) and (m) of Chapter 8 increase the fees for initial grading and grading appeals for coffee from \$1.00 to \$1.25 per bag, as set forth in Exhibit A. As a corollary, the amendments also increase the amount of the fee that will be refunded in the

event the coffee is not graded for any reason. For initial grading, the refund will be increased from \$.50 to \$.62 and the amount of the refund will be increased from \$.30 to \$.40 for an appeal.

Cotton Certification Fee

The Exchange is also increasing the Cotton Certification Fee from \$1.50 per bale to \$2.00 per bale. This fee is not codified in the Exchange's Rules, but is stated in an Exchange publication titled "Cotton Deliverer's and Receiver's Guide", which is available on the ICE website. The Exchange estimates that the Cotton Certification Fee has not been increased in excess of fifteen years and is increasing the fee to compensate for inflation.

eCOPS Documentation Fee

eCOPS is the Exchange's electronic title transfer system for warehouse receipts. The fee for certain eCOPS documentation is being increased by \$0.25 per document and the fee for the Certified Stock Valuation Invoice is being increased by \$3.00 per doucment, as set forth in Exhibit A. eCOPS fees have not been increased since January of 2009.

All of amendments were adopted by the Exchange's Board of Directors by unanimous consent on October 25, 2012 and shall become effective on January 1, 2013.

The Exchange certifies that the amendments to the foregoing fees comply with the requirements of the CEA and the rules and regulations promulgated thereunder. No substantive opposing views were expressed by members or others with respect to these rules. APPENDIX II Procedures for Grading Coffee and Issuance of Certificates of Grade

The following procedures must be followed by Members and Licensees in connection with the grading of Coffee "C":

* * *

(l) Fees.

The fee for grading is hereby established as one dollar (\$1.00) dollar and twenty five cents (\$1.25) per bag of coffee with a minimum fee of twenty dollars (\$20.00) forty dollars (\$40.00).

All fees will be paid by the Person submitting a Sampling Order at the time the Sampling Order is created. In the event coffee covered by a Sampling Order is not graded for any reason, the Exchange will refund to the submitter thereof fifty cents (\$.50) sixty two cents (\$.62) per bag.

(m) Appeal.

The fee for an appeal shall be one dollar (\$1.00) dollar twenty five cents (\$1.25) per bag and shall accompany the Notice of Appeal. If the original decision under appeal is modified, the Exchange shall reimburse thirty cents (\$.30) forty cents (\$.40) per bag to the appellant.
