RE: CFTC Regulation 40.6(a) Certification. Notification of Expansion of Listing Schedules for Eight (8) Petroleum Futures and Option Contracts

Dear Ms. Jurgens:

The New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying expansion of the listing schedules of eight (8) petroleum futures and option contracts effective Sunday, December 1, 2013 for trade date Monday, December 2, 2013. The product titles, Clearing and CME Globex codes, current CME ClearPort/NYMEX trading floor and CME Globex listing schedules, and amended CME ClearPort/NYMEX trading floor and CME Globex listing schedules are set forth below.

Exchange business staff responsible for the rule amendment and the Exchange Legal Department collectively reviewed the designated contract market core principles ("Core Principles") as set forth in the Commodity Exchange Act (the "Act" or "CEA"). During the review, Exchange staff identified that the listing rule amendments may have some bearing on the following Core Principles:

- <u>Availability of General Information</u>: The Exchange will publish information on the changes to the listing cycles on its website and distribute relevant information to customers.
- Execution of Transactions: These contracts are dually listed for trading on CME Globex and on the NYMEX trading floor for open outcry trading, and for clearing through the CME ClearPort platform. The CME ClearPort platform provides a competitive, open and efficient mechanism for novating transactions that are competitively executed by brokers. The CME Globex platform provides a transparent, open, and efficient mechanism to electronically execute trades on screen. In addition, the NYMEX trading floor is available as an additional venue to provide for competitive and open execution of transactions.

Pursuant to Section 5c(c) of the Act and CFTC Regulation 40.6(a), the Exchange hereby certifies that the listing rule amendment complies with the Act, including regulations under the Act. There were no substantive opposing views to this proposal.
