NYSE Liffe – 2009 Exchange Holiday Schedule

Summary

This Notice announces the trading days for the NYSE Liffe market in 2009

1. Introduction

- 1.1 Notice 1/2009, issued August 21 2008, set forth the NYSE Liffe trading hours on U.S. public holidays from launch through New Year's Day, 2009.

2. Exchange Closures

- 2.1 During 2009, the NYSE Liffe market will be open for trading Monday through Friday, except on New Years Day, Martin Luther King Jr's Birthday, President's Day, Good Friday, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas Day. The times of the close of the trading session on the day before, and the opening of the trading session on the day after, for each of these holidays will be as follows:
