Re: Rule Certification. New York Mercantile Exchange, Inc. Submission #10-384: Notification of an Administrative Amendment to Chapter 5, Position Limit, Position Accountability and Reportable Level Table of the NYMEX Rulebook to Correct a Typographical Error for a Natural Gas Contract

Dear Mr. Stawick:

The New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying an administrative amendment to the Position Limit, Position Accountability and Reportable Level Table located in the Interpretations and Special Notices Section of Chapter 5 of the NYMEX Rulebook. The amendment is intended to correct a typographical error in the expiration month limit for the Florida Gas Zone 3 Natural Gas Index Swap (Platts Gas Daily/Platts IFERC) futures contract (Chapter 447, Contract Q9). The expiration limit for the contract should be 500/500, rather than 500/50, in order to accurately reflect the expiration month limit of 500 contract units of the underlying contract.

Pursuant to Section 5c(c) of the Commodity Exchange Act ("Act") and CFTC Rule 40.6, the Exchange hereby certifies that the attached rule amendment complies with the Act, including regulations under the Act. This change will be made effective on trade date December 29, 2010.
