Rule Certification. New York Mercantile Exchange, Inc. Submission # 10-387: Notification of Housekeeping Rule Amendments for Petroleum Swap Futures Contracts

Dear Mr. Stawick:

The New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying administrative, non-substantive, amendments to the rule titles for the petroleum futures contract listed in the table below.

The contract, commodity code and rule chapter are as follows:

Contract	Code	Rule Chapter
Northwest Europe Fuel Oil High-Low Sulfur Spread (Platts) Swap Futures	FS	665

The amendment to the rule title for the above-listed contract is comprised of the replacement of the term "High-Low Sulfur Spread" with "Diff: 1% NWE FOB Cargoes vs. 3.5% Barges (Platts) Swap Futures" to reflect the correct terminology reported in the Platts index. This amendment is administrative in nature and has no impact on the value of the contract.

In addition, NYMEX is also notifying the Commission that it is self-certifying amendments to the Position Limit and Position Accountability and Reportable Level Table located in the Interpretations and Special Notices Section of Chapter 5 of the NYMEX Rulebook, in order to reflect the changes made to the title of the contract.

Pursuant to Section 5c(c) of the Commodity Exchange Act ("Act") and CFTC Rule 40.6, the Exchange hereby certifies that the amendments comply with the Act, including regulations under the Act. This submission will be made effective on trade date December 29, 2010.
