> Re: Rule Certification. New York Mercantile Exchange, Inc. Submission# 10-390.: Notification Regarding Stop Listing New Contract Months for Midwest ISO Cinergy Hub Contracts.

Dear Mr. Stawick:

The New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying that the reduction of listed contract months for certain Midwest ISO Cinergy Hub contracts. Specifically, the Exchange will stop listing new contract months for the Cinergy Hub contracts listed below. These contracts are currently listed on CME ClearPort and the NYMEX trading floor.

The Exchange has determined not to list new contract months for the Cinergy Hub contracts due to the January 1, 2012 withdrawal of Duke Energy transmission subsidiaries Duke Ohio and Duke Kentucky from the Midwest ISO (MISO). Duke Ohio includes 40% of the transmission nodes that make up the Cinergy Hub as defined by MISO. This future change in the operation of the Cinergy Hub and related pricing has introduced uncertainty in the Cinergy Hub market. Commercial participants have not yet reached a consensus as to the transition of contracts that extend beyond the 1/1/12 withdrawal. Given this, the Exchange has decided to stop listing new contract months in these contract markets.
