Dear Ms. Jurgens:

Previously, pursuant to Submission No. 13-411 dated December 10, 2013, the New York Mercantile Exchange, Inc. ("NYMEX") and Commodity Exchange, Inc. ("COMEX") (collectively, the "Exchanges") notified the Commodity Futures Trading Commission ("CFTC" or "Commission") of plans to extend the existing Energy & Metals ETH & Back Month Globex Volume Incentive Program for High Volume Contributors ("Program").

In this letter, the Exchanges are providing the Commission with certain additional information related to the incentives under the Program. **Re: FOIA Confidential Treatment Request**

Dear Ms. Jurgens:

By e-mail dated today, December 10, 2013, the New York Mercantile Exchange, Inc. ("NYMEX") and Commodity Exchange, Inc. ("COMEX") (collectively, the "Exchanges") submitted a supplemental rule certification filing (Submission No. 13-411S) to the Commodity Futures Trading Commission ("CFTC" or "Commission"). This supplemental filing includes an appendix ("Appendix A"), which is attached.

Pursuant to Sections 8 and 8(a) of the Commodity Exchange Act ("CEA"), as amended, and Commission Regulation 145.9(d), the Exchanges request confidential treatment of Appendix A, on the grounds that Appendix A contains confidential commercial information of the submitter (NYMEX and COMEX). A detailed written justification supporting that request is attached hereto as Exhibit 1. Pursuant to Commission Regulation 145.9(d)(5), the Exchanges request that confidential treatment be maintained for Appendix A until further notice from NYMEX and COMEX. We also request that the Commission notify the undersigned immediately after receiving any FOIA request for said Appendix A or any other court order, subpoena or summons for same. Finally, we request that we be notified in the event the Commission intends to disclose such Appendix A to Congress or to any other governmental agency or unit pursuant to Section 8 of the CEA. NYMEX and COMEX do not waive notification rights under Section 8(f) of the CEA with respect to any subpoena or summons for such Appendix A.
